

## PRIVACY POLICY

Amanda of Overcoming Your Money Maze / Clear, Align and Prosper Pathway™ is committed to protecting your privacy online. This Privacy Policy describes the personal information we collect through this website at [www.overcomingyourmoneymaze.com](http://www.overcomingyourmoneymaze.com), and how we collect and use that information.

### Information We Collect

**Product Orders.** We collect a variety of personal information with each product order. This includes: Your name, country, and email address. **Your payment information.** We collect payments via secure gateways but we do not store payment information on Amanda of Overcoming Your Money Maze / Clear, Align and Prosper Pathway™ servers. All personal information collected for an order is used for the fulfilment of that order and to manage our customer relationship with you.

**Email opt in and free product downloads.** We only collect the email address that you voluntarily provide to us. Your email address is collected in order to deliver the free product. Your name, email address and message are collected when you order to contact us via our contact form. The contact form does not subscribe you to a mailing list, responses will be solely related to your enquiry.

**Activity.** We may record information relating to your use of the Site, such as the searches you undertake, the pages you view, your browser type, IP address, requested URL, referring URL, and timestamp information. We use this type of information to administer the Site and provide the highest possible level of service to you. We also use this information in the aggregate to perform statistical analyses of user behaviour and characteristics in order to measure interest in and use of the various areas of the Site.

**Cookies.** We may send cookies to your computer in order to uniquely identify your browser and improve the quality of our service. The term “cookies” refers to small pieces of information that a website sends to your computer’s hard drive while you are viewing the Site. We may use both session cookies (which expire once you close your browser) and persistent cookies (which stay on your computer until you delete them).

You have the ability to accept or decline cookies using your web browser settings. If you choose to disable cookies, some areas of the Site may not work properly or at all.

### **How Your Information is Used**

The information you provide is used to process transactions, send periodic emails and improve the service we provide. Your information is not shared with any third parties.

### **Third Party Links**

Except as otherwise discussed in this Privacy Policy, this document only addresses the use and disclosure of information we collect from you on our Site.
